- Contestants must be 18 years and older to enter and win.
- Contestants may enter contest by recording a video clip at the Buffalo Chip during the 2014 motorcycle and music festival, and emailing that video to [video@buffalochip.com](mailto:video@buffalochip.com) between the dates of July 28, 2014 and September 30, 2014.
- All entries must be received no later than 5:00 p.m. MST on the 30th of September 2014.
- Maximum length of video entries must be thirty (30) seconds or less to qualify.
- Video clips must be able to be emailed for the submission to qualify and must not exceed 25Mb in file size.
- Use of vulgar or obscene language and/or behavior will disqualify entry.
- Submission of any copyrighted material is strictly prohibited and will void entry.
- Buffalo Chip Campground reserves the right to determine qualification of any video entry. Entries deemed unqualified for use will void that entrant from inclusion in the grand prize random draw.
- Contestants may submit multiple entries within the given time of the contest, however only one entry per person will be included in the random choosing of the grand prize.
- Employees of the Buffalo Chip Campground, any members or family members, are not eligible to enter.
- The grand prize of a 2015 Rally Pass will be chosen at random from all qualified applicants. There will only be one grand prize awarded.
- Email addresses will be used to pick winner at random.
